Completed Projects List

1. ACTIVITY ROOM AND BATHROOMS: \$30,000 – currently under budget
Activity room is refreshed with new floors, paint and lighting.
Bathrooms nearing completion. The all-gendered bathroom is functional but waiting for the urinal. The ladies' room is just waiting for its door.

Special thanks to the donors for the flooring. It looks wonderful.

2. CORDLESS BLINDS FOR WINDOWS IN GREAT HALL \$ 2,800 Complete Adopted, paid for and completed.

3. SANCTUARY TABLES- 4 \$120 EACH

\$480 Complete

This is completed so we have expanded our seating by 25%, which has accommodated our growing attendance. Thank you table donors! Our in-person attendance for the 2nd quarter was up 48% from last year. Average 40 in attendance in 2023, 61 in 2024.

4. CEILING MOUNTED SPEAKERS

\$2400 Complete

The costs for this were adopted and the installation is complete! Thank you donor!

Vision for the Future - PROSPERITY IN MOTION: Up and Coming 2024 Projects Miracles Continue....

Pole Barn Roof

April 17th, we had a hailstorm that caused roof damage. Our insurance company is covering the costs to reroof not only the Pole Barn, but the Great Hall, Lodge, Pump House and Grill roof. We have hired Simon Roofing, and they expect to begin early this fall. This frees up the monies dedicated to reroofing the pole barn to other outside projects. This amounts to a gift of around \$140,000.



Estate Gift

Unity received an additional estate gift of \$35,000 from Nancy Jaehn which will be used for outside projects.

- a. **Urgent Repair:** we are getting water in our kitchen and basement. This can be corrected by a combination of foundation work and grading. We are in the process of getting quotes. *Once this cost is determined, we will prioritize other outside projects.*
- b. Additional Parking pad upper level by Lodge \$5,000 original estimate for 2-3 concrete spaces

 The estate gift must be used for outside projects so we are currently looking at adding blacktop
 parking by the Lodge for an addition 6 or more spaces and expanding the existing 2 parking
 places to 4. Preliminary estimates are around \$10,000

c. PUMP HOUSE ROOF AND PAINT

Donation of \$1000

August/September: Will have new siding, door and window. Roof will be redone by Simon Roofing. Jerry Podany and Tom Cody are creating a hatch door in the roof to accommodate and future pump replacement. (Last year, we had to cut a hole in the roof)

Other suggestions for use of the estate fund include:



- a. Seal parking lot and paint parking spaces
- b. Video cameras outside for security
- c. Decks repair, refurbishment
- d. Railing off activity room door to backyard for safety, also step great hall back door
- **e.** Parking lot lights change out light bulbs energy efficient, or solar?
